3. **Presentation- Arts and Culture: Project Ideas**

Liaison Margoles: 1) Reported the Connector Project went out to bid on March 14th; 2) Noted the Archway project has been designed and permitted 3) Informed the City has executed the Broward Redevelopment Program (BRP) Grant Agreement for \$150,000; also, spoke about the City's success with the Cultural Facilities Grant for \$500,000 which consists in putting sound up and down Main Street, as well as a fountain in the south end roundabout. This Grant also includes the re-alignment of Main Street to correct the one one-way street and improve mobility; 4) Provided an update on the date for the upcoming Music on Main Street; 5) Invited all Board Members to the April's Culinary Arts Showcase that will take place on Thursday, April 7th.
