Staff Liaison Margoles provided update on the following items:

- a. Three Cultural Facilities Grants (2 new):  
The City has applied for two new grants: one as the City, requesting funding for parking projects on Main Street; and the other as the CRA, requesting funding to hold cultural activities at the Urban Farming Institute.
- b. Connector  
The request to reallocate the Central Market BRP funds was on the May 10<sup>th</sup> County Commission agenda. The reallocation of the \$150,000 to the Connector project was unanimously approved.
- c. Archway  
The construction on the foundation for the Archway and fabrication on metalwork has begun and installation is scheduled to take place in mid-June
- d. Music on Main – new art component  
The next Music on Main Street will be held on May 27<sup>th</sup>. An art component will be incorporated to the June's Music on Main Street event.
