**2. Commercial POP Star Award Consideration – Orion Fuels 1251 NE 45 Street**


- Staff Liaison Fiore provided the Board Members with photos of a proposed commercial Pop Star nomination Orion Fuels located at 1251 NE 45 Street.

- Vice Chair Caraglia will be submitting a commercial Pop Star nomination form and photos for G21 Fitness.


**3. Other Business / Next Meeting:**
